**CIVIL MARRIAGE**

- ❖ *APPLICATION FORM (provided by us. No needed when both names are registered on the certificate of no impediment).*
- ❖ *RESIDENCE PERMIT (if needed)*
- ❖ *COPY OF PASSPORTS*
- ❖ *BIRTH CERTIFICATES (officially stamped and translated into Greek)*
- ❖ *CERTIFICATE OF NO IMPEDIMENT or MARRIAGE LICENSE\* (officially stamped and translated into Greek)*
- ❖ *DIVORCE OR DEATH CERTIFICATE IF NEEDED (officially stamped and translated into Greek)*
- ❖ *COURT DECISION FOR MINORS UNDER 18 (officially stamped and translated into Greek)*
- ❖ *MARRIAGE'S ANNOUNCEMENT (Publication in the local newspaper - names in Greek letters - 8 days before the ceremony. No needed when both names are registered on the certificate of no impediment).*
- ❖ *100 EURO MUNICIPAL TAX ONLY IF CEREMONY WILL TAKE PLACE ANY FRIDAY (FOR FRIDAYS FROM 13:00 TO 15:00 EITHER BY THE LAKE, OR IN THE MUNICIPAL OFFICE)*
- ❖ *15 EURO TAX STAMP FOR EACH (No needed when both names are registered on the certificate of no impediment).*
- ✓ *DURING THE MARRIAGE , THE COUPLE MUST HAVE THEIR I.D. / PASSPORTS AND TWO WITNESSES ( over 18 and with I.D./ passport)*
- ✓ *THE MARRIAGE MUST BE REGISTERED WITHIN FORTY DAYS OF THE WEDDING DAY*
- ✓ *MARRIAGES CAN TAKE PLACE EITHER:*
  - ❖ *ANY FRIDAY FROM 13:00 TO 15:00 EITHER BY THE LAKE, OR IN THE TOWN HALL (7 R.Kapetanaki str. ) OR*
  - ❖ *EVERY TUESDAY, THURSDAY & FRIDAY AFTERNOON BY APPOINTMENT ONLY WITH*
  - ❖ *MUNICIPAL FEE 400 EUROS.*

**NOTE 1:**

*ALL FOREIGN DOCUMENTS (BEFORE TRANSLATED) MUST BEAR THE HAGUE STAMP "APOSTILLE" (FOR DOCUMENTS OF COUNTRIES WHICH HAVE CONCLUDED THIS CONTRACT)  
FOR THE REMAINING COUNTRIES, INSTEAD OF THE HAGUE STAMP, AN ATTESTATION OF THE SIGNATURE OF THE PERSON SIGNING THE FOREIGN TEXT IS REQUIRED FROM THE GREEK*

*CONSULATE IN THE COUNTRY OF ISSUE OF THE CERTIFICATE OR FROM THE CONSULATE OF THE COUNTRY ITSELF IN GREECE AND THEN FROM THE MINISTRY OF FOREIGN AFFAIRS.*

**NOTE 2:**

*ALL FOREIGN DOCUMENTS MUST BE OFFICIALLY TRANSLATED INTO GREEK FROM THE GREEK CONSULATE IN THE COUNTRY OF ISSUE OR FROM THE TRANSLATING SERVICE OF THE GREEK MINISTRY OF FOREIGN AFFAIRS IN ATHENS OR FROM A GREEK LAWYER*
